Celebrate & Live the Call to Leadership



During the months of June, July and August, Conferences and District Councils are often called upon to select a new President. Nominating committees find themselves praying as they sort through the names of Conference and/or Council members who are eligible to hold office in hopes of finding one or two Vincentians who are willing to step forward and serve as President.

Perhaps, just perhaps, this process of looking for new leadership is a little backwards. Leadership is a special and unique call from God; a call that comes with all the resources those called will need to serve. The call begins with Spirit of the Lord as it resounds in the heart of the person being called. As

followers of Christ, each and every person is called to spread the Gospel, to serve, and to lead. At different times in our lives, that call will be manifested in various ways. Each call comes in its own time and in its own way.

Discernment is one of the fundamental elements of the Society of St. Vincent de Paul. And yet, even though this word is commonly used, it is many times misunderstood. Discernment is the quality of being able to grasp or comprehend that which is obscure. In other words, you and I are called to see beyond the obvious, to see with the eyes of faith. We are called to move beyond our comfort zone and to be willing to trust in God and His faithfulness.

A call to leadership may come as a gentle whisper deep within our hearts or a clanging voice that will not be silenced. It may come as an invitation from a friend or inspiration gained from a scripture reading or an article. It may even come through the process of elimination where no one else is willing or able to serve. But regardless of how it comes, a call from God is a sacred call and one that needs to be answered.

As Vincentians, we are called to regularly discern our vocational call, to take stock of our gifts and how they can be used, to evaluate our decisions related to those whom we serve, and to discern who God is calling to leadership positions. We serve in faith and hope; believing that all that we need has already been provided. God has sent us the leaders we need, called them by name, and empowered them to lead us.

During the election process, the Conference or Council and its members need to discern what leadership qualities the group needs at this moment in time. Each leader brings with them a distinct set of skills and gifts, and often the question becomes are these the gifts our Conference or Council needs today.

No one becomes President of a Vincentian Conference or Council by accident or just because no one else would do it. Not really. The providence of God not only guides us, but our Conferences and Councils as well.

If you are called to be a Conference or Council President accept it, name it, claim it, celebrate it and live it. If God needs you to serve His people, how can you refuse His invitation?

The Society of St. Vincent de Paul National Assembly will be held in Houston, Texas August 25th through August 28th. Attending the regional and national meetings is a great way to learn more about the Society, to listen to inspiring speakers, to revitalize your vocational call, and to interface with Vincentians from across the United States.

The cost for registration for the full four days is \$375 if you register by July 15, \$425 if you register after July 15th and before August 15th and \$475 after August 15th. Hotel accommodation can be made at the Marriott Marquis Houston at a group rate of \$155 a night if your reservation is made before August 4th. The cost for this event may seem a little pricey but it is well worth the expense. It is important to note that conferences and councils may vote to pay for some or all of the expenses of their delegates and/or members. (See the National Q & A response to the reimbursement policies of the Society below.)

Being a Vincentian is not just about serving the poor. It is also about growing in holiness through not only service but through fellowship and being part of the larger Vincentian family. Learning, growing and building relationships with our brother and sister Vincentians from other areas of the United States enlivens and enriches us and our works. It helps us to see the bigger picture, to hear new ideas and to share our experiences in ways that may help others.

If attending the meeting doesn't seem that enticing, keep in mind that our Phoenix Diocesan Council is scheduled to host the 2022 National Assembly. Having a large delegation from Phoenix attending this one will provide us with valuable knowledge and insights into how we can make this event even better next year. Additionally, three of the workshop presenters for the Houston assembly will be from the greater Phoenix area, so why not attend and support them?

(National Q & A 4/17/2014 Page 24) - The Rule, Part III, Statute 28 states: *Vincentians entrusted to undertake previously and duly authorized offices, missions, or tasks for the Society are entitled to the refund of the expenses incurred.* This is more than just an entitlement. Within the Spirit of the Society, all the works of the Society are works of the group and not the individual. If a member does not get reimbursed for expenses, the work becomes an individual effort and this often causes confusion when members then do what they want rather than what is agreed to by the Conference or Council. This does not directly address National and Regional meetings; however, in Part II of the RULE, International Statute 7.4: "Any matter that is not specifically governed by any Parts of the Rule and Statutes shall be governed by Tradition and, in the final instance, by the decision issued by the Board of the Council General." That said, on page 136 of the 2002 version of the manual, it states: "In accord with the long established practice, the individual Councils and Isolated Conferences are expected to assume financial responsibility for their delegates and committee members to attend meetings as necessary."

Election Procedures for SVdP Conference or Council Presidents

Throughout the various levels of the Society of St. Vincent de Paul, the only elected office is that of President. The newly elected President in consultation with the Conference or Council membership appoints all other officers. <u>The outgoing President</u> or the clergy of a given parish may not under any circumstances appoint a Conference or Council President.

The election of Conference and Council President is held by secret ballot in accordance with an approved set of procedures that are consistent with the Rule, Statutes and Bylaws of the Society.

The term of office of a Conference, District or Diocesan Council President is three years, once renewable... Once a President has served two consecutive three-year terms, that person will not be eligible for re-election as President until a three-year term has elapsed under a different President.

Each Conference or Council should have at least a Vice President, a Secretary, and a Treasurer all of which are appointed by the President after consultation with the members. The President may appoint other officers.

All officers appointed by the President serve at the pleasure of the President, Such appointment terminate automatically when a new President takes office. An incoming President may reappoint an officer or officers and others who served under the previous President. (Rule Part III: 12)

In most cases, the First Vice President of a Conference or Council serves as the chairman of a nominating committee. Depending on the size of the Council or Conference, two or four members should be appointed to serve on that committee. The purpose of the committee is to determine who is eligible and interested in becoming a Presidential candidate and to interface with Conference or Council members about Vincentians who they believe have demonstrated leadership qualities and shown an interest in becoming an officer. Potential candidates are contacted and asked if they are willing to run for the office of President. Individual Vincentians may also contact the nominating committee and express their interest in running for office.

As soon as eligible candidates have been obtained, the date for an election must be set and all voting members must be notified of the upcoming election date. *The President is then elected by secret ballot and only full-enhanced members who are present at the meeting may cast a ballot. No absentee ballots may be issued or counted*. Once the process has been completed, arrangements should be made to commission the newly elected President.

In the Diocese of Phoenix, all newly elected Presidents take office on October 1st and serve through September 30th. In the event that a President resigns or otherwise vacates their office prior to the end of their term, an interim President is elected to serve until September 30. A new full term President is then elected to take office on October 1st. No interim Presidential term shall be counted in the term limit for a given Vincentian.

We ask all these things through the power of your Holy Spirit and in the name of Your Son, our Lord Jesus Christ. Amen

Co-Presidents:

Please note that co-presidencies are a last resort and highly discouraged for the Conferences in the SVdP Diocesan Council of Phoenix. Such positions are not recognized at the National level and can only even be considered at the Conference level. If one of the co-presidents steps down, that person cannot be replaced during that term as they were elected as one entity with their partner president. It is also impossible for two people to be of one mind. Often one co-president carries more of the responsibilities of the office and the other just goes along with the stronger of the two. According to our Conference bylaws, having co-presidents requires proof of a hardship and the advance approval of the District president.

The most effective slate of officers is a president with a strong vice-president. Keep in mind that the 1st vice president of any Conference or Council automatically assumes the duties of the president in his/her absence. It should also be noted that other officers may be re-appointed by an incoming president and that these positions have no term limits. It is, however, in the best interest of the group, to periodically change the people serving in those positions.

Vibrant Can Be A Vincentian Quality!



Have you ever thought or referred to your Conference as vibrant? Well, our Diocesan aggregated youth Conference not only thinks of themselves as vibrant, they included that word in their very name - ACS Vibrant Vinnies. The word vibrant is not just a part of their name, their members bring that word to life on a regular basis. Even during the pandemic, this Conference was so vibrant that they had to cap the number of their members in order to keep their Conference from growing too large. How many of our

adult Conference have ever experienced this problem? Additionally, this vibrant Conference is never at a loss for members interested in filling officer positions including that of president.

Just a few months ago, these young Vincentians hosted a District 11 meeting. They decorated the meeting space, provided the evening meal, welcomed the attendees at the front door and escorted them to their seats, held a raffle for a prize they came up with, and had twenty-three of their members attend all or at least part of that meeting. It can easily be said that these young Vincentians bring a unique energy and enthusiasm to the Society that should inspire and challenge all of us. Vibrant Vinnies Conference has stayed very busy during the pandemic. We have continued to help at the food pantry at St. Joan of Arc, the new Hope Chest Thrift Store, and helped sort food at the warehouse at Watkins. We have also had two clothing drives, a food drive that brought in 800 pounds of food, and assembled and passed out blessing bags to our homeless. Currently we are collecting backpacks and Band-Aids that will be donated to Sunnyslope in a few weeks.

Our May meeting included the Vinnies assembling 150 blessing bags that were passed out at Sunnyslope and outside Ozanam to any who wanted one. Our Conference raised the funds and purchased the items needed for the blessings bags which included, sunscreen, socks, lip balm, granola bars, water, rosaries and religious cards. Our current Conference president, 8th grader Natalia stated, "I love serving others because it puts a smile on my face and the faces of people I serve!" The Vinnies passed out the bags as many waited for a shower and they were all so appreciative. Some of the homeless simply needed a hug. We then went into Sunnyslope and helped sort shoes, clean the floors, and even did some filling in the office.

This past week we had a great opportunity to play Bingo with the residents at Ozanam Manor. The Vinnies enjoyed sitting next to the residents playing the game and socializing. Sabini, a 7th grade

Vinnie said, "can we come back and do this every week?" The Vinnies made patriotic cards that were passed out to residents thanking many of them for their service. We also brought in donations of towels and bed sheets, which they were especially grateful.

Our outgoing President, River Vogelsang, has graduated from Vibrant Vinnies but hopes to start a Conference at his high school. River reflects on his 4 years in Vinnies as the "best thing I have ever done." "I learned to not judge and look for the face of Jesus in everyone I encounter and I feel so good after the Vinnies projects." His sister is following in his footsteps and is now the Conference Vice President. Meadow has stated, "I watched my brother grow in his faith and love serving others for the past few years and I wanted to be involved, I want to help change the world!"

The world has changed in many ways, but to the children of Vibrant Vinnies, serving has not stopped and is more important than ever.
