The Society of St. Vincent de Paul Homelessness Prevention (HP) for Conferences Update Effective 8/1/24

The following information is to provide important updates to the HP for Conferences program.

1. As our Homelessness Prevention Program (HPC program for conferences) continues to evolve and expand, we are increasingly aware of the need to collect data that evaluates the effectiveness of our services. With that in mind, we are now requesting Conferences to complete the additional documents required for the research initiative with Arizona Housing Collaborative (AzHAC). This additional documentation is fairly simple to submit and not complex in nature. The research project we are participating in focuses on analyzing homelessness prevention programs and processes. In addition to providing us with data, our participation may assist us in securing additional funding opportunities.

Exceptions can be made for cases where the family is unwilling or unable to provide the supplemental documentation needed for this research project. Our goal is to support Conferences in their efforts to prevent homelessness, so please feel free to ask for special accommodations for families that fall outside of the research project requirements.

Note: The two additional documents, the Neighbor Assessment and Data Sharing Consent forms, that are being requested are listed below. If your neighbor chooses not to participate in the research project, HP will attempt to help with other funds. Keep in mind, that the majority of available assistance funds will now be linked to the AZHAC project.

2. The Council is attempting to use resources as equitably as possible - spending money where the greatest need and fewest other options exist. Please be aware that there are limited funds to be shared among 80 conferences

Process:

Maximum Payment Amounts per household:

- Rental/Mortgage Assistance Up to \$2,500 per year
- Other Utilities \$500 per year
- Total Amount of Assistance per Household per year \$2,500
- Additionally, Wildfire Utility Assistance may be available as follows:
- Wildfire -APS Can only pay balance due, up to \$1,000, 2 applications per year
- Wildfire SRP Up to \$600, 1 application per year
- Wildfire SWG \$400, many applications per year

Please note:

HP uses various grant funds, as they are available, to serve neighbors. If additional documents are required by grants, you may receive a request for additional documents. Thank you for your cooperation and patience here.

After the application and all documents are received, conference members will be notified of the status of the application within 48-72 hours.
