The Society of St. Vincent de Paul is an international non-profit organization dedicated to serving the poor and providing others with the opportunity to serve. Through 85 parish conferences the Phoenix Diocesan Council has been assisting central and northern Arizona families since 1946. Programs include services for the homeless, medical and dental care for the working poor, (Continued on Schedule O, Statement 3)

Food Box and Charity Dining Rooms - In Tax Year 2017 approximately 10.4 million meals were provided at charity dining rooms in the Phoenix Metropolitan and Northern Arizona through the emergency food box program. Over 140,000 volunteer hours were provided by individuals and organizations.

**4b** (Code: ) (Expenses \$ 5,845,657 including grants of \$ 0) (Revenue \$ 5,534,755)

Thrift Stores - Donated items are provided to the poor at little or no cost to the customer. Donated items are marketed through 17 thrift stores in Central and Northern Arizona. Those seeking assistance are able to obtain vouchers for free goods based on assessed needs by members of the charitable conferences of the Society. Others are assisted by the availability of low cost goods that they may not otherwise be able to afford. The donated goods are diverted from the waste stream and reused or repurposed. The program employees approximately 65 people and the community provided 38 thousand volunteer hours during the year. Over \$500,000 in goods were provided to those in need during the year.

Medical and Dental Clinic for the poor. Provides nearly 17,000 patient visits each year. Services include diabetes, oral care, vision services and orthodontia. Local health care professionals provided over 20 thousand hours of care for patients in during the year. Value of in kind services received was \$1.9 million. Total market value of services provided is approximately \$5 million. Over 22 thousand volunteer hours were provided by the community in the Medical and Dental Clinic.
