The Society of St. Vincent de Paul is an international non-profit organization dedicated to serving the poor and providing others with the opportunity to serve. Through 85 parish conferences the Phoenix Diocesan Council has been assisting central and northern Arizona families since 1946. Programs include services for the homeless, medical and dental care for the working poor, (Continued on Schedule O, Statement 2)

Food Box and Charity Dining Rooms - In Fiscal Year 2014 approximately 1.5 million meals were provided at charity dining rooms in the Phoenix Metropolitan and Northern Arizona areas. Another 6 million meals were provided through the emergency food box program. Over 145,000 volunteer hours were provided by individuals and organizations.

4b (Code:) (Expenses \$ 6,160,808 including grants of \$ 0) (Revenue \$ 5,336,145)

Thrift Stores - Donated items are provided to the poor at little or no cost to the customer. Donated items are marketed through 18 thrift stores in Central and Northern Arizona. Those seeking assistance are able to obtain vouchers for free goods based on assessed needs by members of the charitable conferences of the Society. Others are assisted by the availability of low cost goods that they may not otherwise be able to afford. The donated goods are diverted from the waste stream and reused or repurposed. The program employees approximately 86 people and the community provided nearly 50,000 volunteer hours during the year. Over \$500,000 in goods were provided to those in need during Fiscal Year 2014.

Medical and Dental Clinic for the poor. Provides over 17,000 patient visits each year. Services include diabetes, oral care, vision services and orthodontia. Local health care professionals provided over 19 thousand hours of care for patients in Fiscal Year 2014. Value of in kind services received was \$1.1 million. Total market value of services provided is approximately \$4.2 million. Over 19,000 volunteer hours were provided by the community in the Medical and Dental Clinic.
