**Society of St. Vincent de Paul**

The Society of St. Vincent de Paul is an international organization spanning 142 countries that aids 37 million people each year. A young man named Frederick Ozanam founded the Society in France in 1833. The Phoenix Diocesan Council of the Society of St. Vincent de Paul has been reaching out to people in need throughout central and northern Arizona since 1946. We are dedicated to serving the poor and providing others with the opportunity to serve, regardless of race, creed, age or other distinctions.

**General Assistance**

Through our Conferences of Charity, a network of community volunteers, we are able to provide food boxes, rent and utility assistance, and other basic items. Last year, more than \$8.6 million in direct aid went to needy families and individuals. This assistance is often a last defense against homelessness for families trying to make ends meet.

**Food and Meals Programs**

To help alleviate hunger among families and children in Arizona, the Food Reclamation Center collects and

processes food items donated by area grocery stores and community food drives. Last year, we processed more than nine million pounds of donated food through our centers. This food goes into emergency food boxes and is distributed through our Conferences or used to prepare the meals served in our charity dining rooms. Last year, we served more than one million meals to homeless and working poor men, women, and children.

**Homeless Assistance and Prevention**

Our Special Works Ministry offers a variety of services to the homeless, the unemployed and those in financial crisis. From showers, haircuts, clean clothes, job referrals and transportation, to budgeting classes, or rent and utility assistance, we help those who are homeless get back on their feet and prevent others from becoming homelessness.

**Medical and Dental Clinic**

Our Virginia G. Piper Medical & Dental Clinic provides medical and dental care to working poor, uninsured adults and their children. Services include primary and specialty medical care; education and

prevention programs; and dental care for adults and children. Last year, the Clinic handled more than 15,000 patient visits. Approximately 160 medical professionals volunteered over 17,000 hours to provide this essential healthcare.

**Ozanam Manor**

Ozanam Manor is the only shelter in Arizona that assists an especially vulnerable group of homeless adults; those over age 50 or those with mental or physical disabilities. This 49-bed shelter provides intensive case management and a supportive environment to help residents successfully transition into permanent housing.

**Thrift Stores**

Our 17 thrift stores provide new and gently-used clothing, furniture and household items for purchase at affordable prices. For some families, direct assistance is provided at no cost. The market value of this direct assistance reached almost \$160,000 last year. We rely on the donation of household goods from the community to stock our stores.

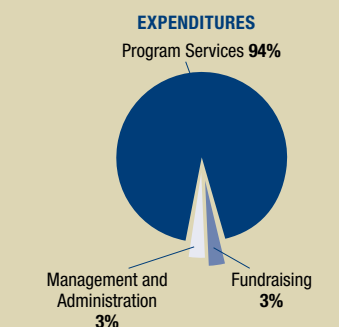
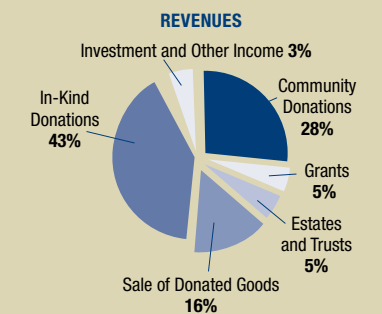
